



The State Troopers Superior Officers Association is pleased to announce that we are providing funding for a scholarship program to benefit qualified college bound children of active full-time members of the State Troopers Superior Officers Association including Captains and Majors. The 2010 scholarships are being made available only to qualified high school seniors entering their freshman year of college.

Applicants for this scholarship must complete a Scholarship Program Application form and send it to the specified address. The application must be postmarked no later than **May 28, 2010**. Applicants must adhere to the provisions outlined on the applications form to avoid potential disqualification.

The program will be administered by a committee chosen by the executive board of the Superior Officers Association. A scholarship in the amount of \$1,000 will be awarded to ten finalists based on the decision of the scholarship committee. The determination of the committee will be based on a number of objective and subjective criteria and will be final.

Selection Criteria will be based on the following items:

- Scholastic Achievement
- Review of Applicant Statement
- Verification of Qualified Parent/Guardian
- Review of Applicant Activities
- Ranking of Qualifications
- Review of Overall Application
- College Costs, including siblings
- Application Completed as Required
